## 2. Privacy law

The Privacy Policy document has been invoked to protect the users of websites and mobile applications. Personal data of the user is acquired in various ways, directly or indirectly, when surfing or using applications. To this end, the European Union has commissioned certain organizations, the GDPR (General Data Protection Regulation) and the EU Cookies Directive, to guarantee this aforementioned protection through strict regulations that are included within European legislation.

The GDPR obliges the data controller, AirSmart, to prepare a Privacy Policy document so that you are protected by law when using our mobile application. Below you will find a summary of which legislation is applied for your protection.

### GDPR

#### Article 5(1) – Data processing and storage

- (a) Your personal data will only be processed in a legal, fair, transparent and non-misleading manner.
- (b) Your personal data will only be used for the proper functioning of our application so that you can make optimal use of it. These will only be used for what you have consented to or expect to be used for.

A username is requested for the user to distinguish between the possibly logged in profiles.

A password is requested to protect the user's preset values.

A first and last name, address and telephone number are requested in order to identify the user so that we, AirSmart, can guarantee an after-sales service for the maintenance and possible interventions of the installation and thus enable the user to comply with the warranty

conditions. In order to have interventions carried out, we must be aware of the address of the user. In order to inform the user in time regarding the necessary maintenance or service interventions, we must have contact details of the user, such as telephone number and e-mail address.

The user's location is requested to inform the user of the air quality and weather forecasts of his environment. With this information the user can make optimal use of our application.

- (c) Your personal data will only be used for the proper functioning of this application so that the user can use it optimally. No additional and unnecessary personal data will be requested that are not necessary for the proper functioning of the application for which it was created.
- (d) Your personal data will be obtained in a way that the chance of incorrect entries is as minimal as possible. We, AirSmart, will try to keep the data up to date on a regular basis.
- (e) Your personal information will be kept by us, AirSmart, for as long as necessary. This duration depends on the use of the registered AirSmart device with the registered client, up to a maximum duration of 5 years.
- (f) Your personal information will be stored in a secure manner. When we, AirSmart, are addressed by data authorities, we, AirSmart, will be fully prepared to cooperate. In the event of possible breaches or insecurity regarding your personal data, we will inform the data authorities as soon as possible.
- (g) Your personal information will be shared with educational third parties who use your location, who, like AirSmart, comply with Apple policies.

#### Article 6 – Lawful basis for data processing

Your personal data will only be processed by us when giving your consent and/or for our, AirSmart's, interests if it does not override your interests.

#### Article 7 – Consent

We, AirSmart, request consent to process your personal data in a non-paying and non-misleading manner. When different purposes arise, we, AirSmart, will ask for your permission again for each purpose where your personal data is requested. This permission can be easily withdrawn at any time.

#### Article 8 – Children

Children under the age of 16 require a parent or guardian for permission to share their personal information. Persons over the age of 16 may give their consent, which also falls under the legalities of the GDPR.

#### Article 15 – Right to information personal data

You have the right to request a copy of your personal information at any time. In addition, you have the right to ask at any time when your personal data is being or has been processed.

#### Article 16 – Correction

You have the right to amend your personal information at any time if it is inaccurate or incorrect.

#### Article 17 – Erasing personal data

You have the right to have your personal data erased at any time if you become aware that the data processing has an unlawful basis.

#### Article 18 – Restriction of data processing

You have the right at any time to limit the processing of your personal data to a desired level.

#### Article 20 – Data portability

You have the right at any time to request a copy of your personal information and to use it for other organizations.

#### Article 21 - Refusal

You have the right to refuse certain data processing at any time.

#### Article 22 – Human intervention

You have the right to request intervention at any time if certain algorithms cause your personal data to be processed incorrectly or in a harmful way.

#### Article 82 – Compensation for damage

You have the right to compensation from us, AirSmart, if your personal information has been misused, stolen or unlawfully processed.

#### EU Cookies Directive

##### Cookies

Cookies are small text files with a certain duration that are placed on your hard drive or mobile phone when you use a website or application with your consent. These text files contain information about your surfing behavior and interests. They simplify the visit and improve the ergonomics of the dialogue. If these are offered to you, this will be done in a free and non-deceptive manner.

If you do not wish to receive cookies, you can choose "do not accept cookies" in your browser settings. You will then no longer receive cookies. However, this can lead to loss of functionality and loss of user-friendliness of the application.

### 3. Additional information personal data

Your personal information is requested by us, AirSmart, directly through a registration option on the application. In addition, when acquiring additional personal data, you are always asked for your permission, such as when asking for your permission to your location.

Your personal information will not be shared with third parties. The AirSmart application also complies with Apple policy.

Your given consent to the processing of your personal data can be withdrawn in the following way;
